## L2Q-Links to Quality:

- The L2Q Build for CAPE has ended, once we are able to move forward L2Q consultants will begin training with the CAPE portal and L2Q specific functions as well as some participants.
- L2Q has officially awarded 6 Program Administration Links, with several more Educators nearing completion and approval following the revision process.
- L2Q currently has educators working on moving through the Family Partnership and Learning and Development Links, As well as 2 educators planning to work on the Health and Safety Link.

- · Go Team is working with Manhattan City Hall to continue discussions about code changes for the Child Care Business Initiative project. Movement is taking place to remove barriers, but these will take time due to fire marshal code change restrictions. In the end, providers should be able to rent out residential homes or properties that they can utilize solely for childcare programs. Providers will have to register with a limited use permit through the city. As this work continues, the Go Team will continue to share updates.

- •Review Breastfeeding FAQs for new KDHE Regulations
  - o The document aligns with KDHE regulations while expanding on best practices. o Attendees provided feedback, including a suggestion to adjust wording regarding child care facility seating requirements for breastfeeding parents. o The final version will be printed and available at Camp Growing With Children (GWC) Conference in April.

o Office of Early Childhood: Bill includes the establishment of a centralized office to consolidate programs. o Changes to regulations for infant ratios and unlicensed care –

- "a person who maintains a child care home with one provider, if such provider provides care simultaneously to four infants at any time during the licensure year, shall submit proof of completion of at least three hours of such professional development training in an infant-specific subject."
- "Day care facility" does not include an individual who provides care for less than 35 hours per week to four or fewer children, not more than two of whom may be infants, who are not related to the individual by blood, marriage or legal adoption." o Concerns were raised about the impact on infant care quality and safety due to the expanded unlicensed care provisions. o Members were encouraged to stay informed and engage with Kansas Action for Children for advocacy updates.
- Updates & Sharing o Camp Growing With Children Conference: KBC will have informational inserts and resources in attendee bags at the event on April 5 in Wichita.
- o Desiree Streight shared how breastfeeding knowledge has changed how she supports infants in her child care setting, including matching milk feeding to infant sleep patterns.
