What's Going on with the CCPC Board?

Advocacy

Kansas Department of Health and Environment (KDHE) is finishing up their review of the regulations for Licensed Child Care Homes/Group Homes and Centers. KDHE will be making changes to the outdated regulations. KDHE will soon be sharing the regulation changes with providers/early childhood educators. Once the changes to regulations are finalized, KDHE will offer training to educate providers/early childhood educators. These training sessions will be both in-person and Zoom meetings.

After the 2023 Kansas Legislature session did not pass S Sub HB 2344, a special committee was formed to investigate the child care needs in Kansas and solutions. (S Sub HB 2344 was a bill that would have changed license capacity and staff-to-child ratio, among other child care regulations.) The committee that was formed is the Special Committee on Child Care Centers and Child Care Homes. They will be meeting on 9/26/2023 and 10/18/2023. You can watch the meetings live or stream at a later time on KS Legislature - YouTube.


Regional Professional Development

NCA Endorses the Child Nutrition Enhancement Act

The Child Nutrition Enhancement Act was introduced in the House of Representatives by Congressman Greg Landsman and Congresswoman Suzanne Bonamici to *permanently*:

- Provide an additional 10 cent reimbursement for each meal and snack served in the CACFP.
- Eliminate the tiering of family day care homes.
- Allow family day care home providers to claim their own children's meals for reimbursement.

NCA, along with 42 other national organizations, is happy to endorse this historic bill! Take action now - urge your representative to cosponsor the bill to ensure that CACFP operators can continue to provide nutritious meals and snacks to those in

CACFP serving size for breast milk

DID YOU KNOW? Most breastfed infants need approximately 1oz/hour of breast milk when at childcare? Breast milk adjusts nutrition as baby grows so the amount of breast milk needed at 6 weeks is approximately the same amount at 6+ months. In contrast, infant formula only has so much nutrition per scoop so as the child grows, more volume is needed to meet their nutritional needs. If a breastfed baby regularly drinks less than the 4 oz. minimum amount of breast milk required by the CACFP meal pattern, providers may offer less than the minimum amount of breast milk at each feeding as long as more breast milk is offered later when the baby is hungry.

And childcare providers participating in CACFP can receive reimbursement for meals and snacks when provided pumped breast milk for child or if baby is breast on site *even* after the child's first birthday. A win-win for providers and families!

"We have a unique opportunity to realize cost savings for participating child care programs so that they can earn more or reinvest in other aspects of their business, like high-quality curriculum for the young children in their care."

Network Hubs services will be provided by the following organizations:

□ Northwest Kansas Innovation Center: Serving 29 counties in the

Northwest and North Central areas of Kansas.


- ☐ Child Care Aware of Kansas: Serving 39 counties in the Southwest and South-Central areas of Kansas.
- ☐ Community Children's Center: Serving 16 counties in the Northeast area of Kansas.
- ☐ Child Care Aware of Eastern Kansas: Serving 17 counties in the Southeast area of Kansas.
- ☐ The Family Conservancy: Serving five counties in the Kansas City area. Also available to KDHE licensed providers is access to a free 14-month subscription to a Child Care Management Software from either Brightwheel or Playground.

The foundation of most Shared Service Networks is child care management software, which can help providers communicate with families and staff; set up reminders; handle scheduling and calendars; manage billing, reporting, and enrollment; and much more. The software also helps providers determine where additional support is needed, such as janitorial, maintenance, or administrative services.



Book Recommendations



Pumpkin Applesauce

Ingredients

- 6 1/4 cups unsweetened applesauce
- 1 (15 oz) can pumpkin puree
